Information Collected

Dr. Mike Thomson is the sole owner of the information collected at www.drmikethomson.com. Dr. Mike Thomson routinely collects information from our users at several different points on our Web site.

Registration

In order to use membership sites, obtain free giveaways, special reports or newsletter or participate in teleseminar or webinar events a user must first complete the registration form. During registration a user is required to give contact information (such as name and email address). We use this information to contact the user about services on our site for which he/she has expressed interest.

Order

We request information from the user on our order form. A user must provide contact information (such as name, email, and shipping address) and financial information (such as credit card number, expiration date). This information is used for billing purposes and to fill customer's orders. If we have trouble processing an order, the information is used to contact the user.

We receive and store any information you enter on our Web site or give us in any other way. You can choose not to provide certain information, but then you might not be able to take advantage of many of our features.

Uses of Information

We use the information that you provide for such purposes as responding to your requests, customizing future shopping for you, improving our stores, and communicating with you. **We will not share your information with any third parties.**

Automatic Information: We receive and store certain types of information whenever you interact with us. For example, like many Web sites, we use "cookies," and we obtain certain types of information when your Web browser accesses www.drmikethomson.com "Cookies" serve the additional purpose of

preventing our software from repeatedly sending the same banner ads to the same customers, and allows our software to customize newsletter and Web page content based on visitors' browser type.

E-mail Communications: To help us make e-mails more useful and interesting, we often receive a confirmation when you open e-mail from Dr. Mike Thomson if your computer supports such capabilities.

We also compare our customer list to lists received from other companies, in an effort to avoid sending unnecessary messages to our customers. If you do not want to receive e-mail or other mail from us, please follow the opt-out instructions below.

We sometimes use an outside shipping company to ship orders, and a credit card processing company to bill users for goods and services. These companies do not retain, share, store or use personally identifiable information for any secondary purposes.
